



My reasons for wanting to withdraw the complaints are as follows:


I have come to the realization that working for the State of Ohio was a mistake on my part. Therefore, I will never again apply for either testing or positions within the State. My current job is the exception, but layoff is rumored to be imminent and I would never want to work anywhere else within the State. Therefore, this makes my complaints moot. If I am still on certification eligible lists for Fiscal Officer 1 & 2, I want my name to be removed.

I don't know why I had mistakenly held the opinion that I was as qualified for and deserving of advancement as others at or below my level of education and work experience, but I have seen the light. Despite being repeatedly rejected for advancement, I stubbornly used various means at my disposal to try to achieve this, such as grieving non-selection, equal opportunity complaints, and even complaints to your office. I was minimally successful and, in so doing, incurred the wrath of both management and even other collective bargaining unit employees. As a result, I was the subject of serious allegations and required to submit to disparate treatment in order to retain employment.

I do not want a hearing. Even if I did, I have just recently learned that my legal counsel had a conflict of interest because they represent the State of Ohio on occasion. I have since discharged them. Even if I were not poor, legal expense would not be justified. I did not plan to work much longer, anyway.

I apologize for the inconvenience that processing these cases to date has caused you.
