Dear Sirs;

I am requesting the appeal filed in re: Case Nos. 09-REC-03-0177 & 09-RED-03-0178 be withdrawn. I am basing this request on the current events in my life which I believe show just cause for such an action.

Much to my regret, my cancer has reasserted itself, my wife is awaiting a decision on major surgery, and less important, I have decided to retire effective February 26, 2010. Given the uncertainties in my life and the need to focus on my family, I simply do not have the energy to continue in this action.

I continue to believe and to assert that the Hamilton County Personnel Department and the Hamilton County Department of Job & Family Services [JFS] violated procedures set forth in Chapter 124-7-01[A][1] Job Abolishments and Layoffs and OAC 123:1-3-01[N] Position Audits. The parties conducted a job audit while in the midst of conducting lay-offs. As the JFS leadership states they have no formal lay-off plan and are reacting to the "fluid" nature of the budget cuts by the Ohio Department of Job & Family Services, I contend that all job audits performed during this period must be treated as if a formal plan is in effect and the potential for lay-off of any position requires compliance with said rule, to wit;

"[N] Audits of positions of incumbents who are subject to layoff or displacement. Requests for audits of positions will not be processed if the position is classified in a classification that is designated for calculation of retention points for purposes of a layoff or position abolishment under the provisions of Chapter 123:1-41 of the Administrative Code..."

All of this said, I respectfully request my request for withdrawal of the appeal be granted.
