Appellant Kathleen M. Fox was the Executive Director of the Ohio Cultural Facilities Commission (“OCFC”) for twenty years, until the abolishment of the OCFC effective July 1, 2013, by June 28, 2013 action of the General Assembly. Appellant was an employee of the State of Ohio when the OCFC was abolished. Prior to abolishment, the OCFC entered into an Employee Exchange Agreement pursuant to R.C. 124.389 with the German Marshall Fund of the United States (“GMFUS”). Appellant was providing services to the GMFUS pursuant to this Exchange Agreement while simultaneously performing her duties as Executive Director of the OCFC. Appellant was not and never has been a contract employee of the OCFC, nor an employee of the GMFUS. However, Appellant hereby voluntarily withdraws her appeal to the State Personnel Board of Review.
