

ORDER


This matter came on for consideration on the Report and Recommendation of the Administrative Law Judge in the above-captioned appeal.

REPORT AND RECOMMENDATION


To the Honorable State Personnel Board of Review:

This cause comes on for consideration due to the Appellee's April 30, 2013, filing of motion to dismiss regarding the above-captioned case. The motion to dismiss contained: a memorandum in support; the affidavit of Dave Colleti, Appellee's Chief Executive Officer at the Northcoast Behavioral Healthcare facility; along with various accompanying documentation; and pertinent case law. Appellant was provided with the requisite amount of time to file a memorandum contra to Appellee's motion to dismiss, but, to date has not done so.

O.A.C. 124-11-07 sets forth the motions practice before this Board. O.A.C. 124-11-07 (A)(2) indicates that when a party files a dispositive motion, then an adverse party must respond affirmatively and show that there is a genuine issue in dispute. O.A.C. 124-11-07 (C) sets forth a ten-day time frame to respond to dispositive motions, such as the instant motions to dismiss. Appellant has failed to file the required response to Appellee's motion to dismiss and thus, has failed to comply with O.A.C. 124-11-07. Furthermore, Appellee's jurisdictional arguments that addressed the above captioned appeal appear to have merit, as the Appellant herein was alleged to be employed as employee in the unclassified service pursuant to Ohio Revised Code section 124.11 (A) (14).
