

ORDER


This matter came on for consideration on the Report and Recommendation of the Administrative Law Judge in the above-captioned appeal.



This matter came on for consideration on December 10, 2013. Appellee Department of Job and Family Services appeared and was represented by Nicole Moss, Senior Staff Attorney.
