

**ORDER**


These matters came on for consideration on the Report and Recommendation of the Administrative Law Judge in the above-captioned appeals.



**REPORT AND RECOMMENDATION**

To the Honorable State Personnel Board of Review:

This cause comes on pursuant to Appellee's Motion to Dismiss, filed with this Board on October 16, 2013, and Supplemental Information filed by Appellee in response to this Board's Procedural Order, filed on February 6, 2014. Appellant filed additional information with the Board on February 12, 2014.

Appellee asserts that this Board is without jurisdiction to consider the above-referenced appeals because the R.C. 124.34 Order of Involuntary Disability Separation effective August 28, 2013, from which the instant appeals arose, was rescinded. A second Order was provided to Appellant with an effective date of October 2013; that involuntary disability separation is the subject of SPBR Case No. 2013-IDS-10-0270, currently pending before Administrative Law Judge Marcie Scholl. Appellant does not dispute Appellee's assertion that the August 28, 2013, Order was rescinded.

Therefore, I find that Appellee's rescission of the R.C. 124.34 Order of Involuntary Disability Separation effective August 28, 2013, rendered the above-referenced appeals moot, and I respectfully **RECOMMEND** that the instant appeals be **DISMISSED**.
