


This letter is in reference to my appeal I filed with the State of Ohio, State Personnel Board of Review on December 5, 2014. This is to serve as notification that since I have filed my appeal this matter has since been resolved with my employer (Appellee) Hamilton County Sheriff's Office as of January 14, 2015. Therefore, respectfully I will no longer need your assistance in this matter and I apologize for any inconvenience this may have caused.

Unfortunately I had to proceed and file an appeal so I could still have this option available to me if the matter could not be resolved and that I still felt the matter needed to be reviewed by the State Personnel Board of Review. At the time I was only informed that my employer needed to review the matter further and they would let me know when they have made their decision.

Since receiving notification that my appeal has been received my employer has offered me to be reclassified and placed in the Account Clerk 3 position at 22.6950 hourly, \$47,205.60 annual retro to the date they state I filed my audit request 08/28/2014. This placed me in the Specialist pay scale, 3 year level with 2% Longevity. I will move through the scale on my anniversary date (08/28/2014) for the Account Clerk 3 position. This was offered to me with the understanding the classification of Account Clerk 3 will be excluded from the BEHCS bargaining unit. I accepted their offer.

I greatly appreciate your assistance in this matter and again I am sorry for any inconvenience this may have caused.
