



NOTICE OF RESCISSION AND REMOVAL

Appellee Ohio State University notifies the Board of its rescission of Appellant's June 2, 2014 notice of rescission and May 30, 2014 Removal Order pursuant to R.C. 124.34, and reissue of rescission and new order of removal. On June 2, 2014, Appellee mailed to Appellant via certified mail notice of the June 2, 2014 rescission (Exhibit 1) of its March 13, 2014 removal.¹ (Exhibit 2.) Appellee then issued a new Order of Removal, effective June 6, 2014.² (Exhibit 3.) However, Appellant did not receive notice of the Order of Removal before its effective date of June 6, 2014. (Exhibit 4.) In another letter dated June 30, 2014 (Exhibit 5), Appellee rescinded the June 6, 2014 Order of Removal and issued another Order of Removal, effective July 13, 2014. (Exhibit 6.) Appellee notified Appellant that it will restore her benefits and back wages from her original date of termination, March 13, 2014, to July 13, 2014. (Exhibit 5.) Appellant received the June 30 Order of Removal on July 7, 2014, prior to its July 13, 2014 effective date pursuant to O.A.C. 124-3-01(A)(2). (Exhibit 7.)




