





RESPONSE TO PROCEDURAL ORDER


Appellee Ohio State University hereby responds through counsel to the Procedural Order issued by the State Personnel Board of Review on June 17, 2014. Appellant Laura Frankart's termination that is now before the Board was rescinded on June 19, 2014. (Exhibit 1.)
