



SETTLEMENT AGREEMENT AND RELEASE OF ALL CLAIMS

This Settlement Agreement and Release of All Claims (“Agreement”) is made and entered into by and between Appellant Karen Thompson, and Appellee the Ohio Department of Taxation.

WHEREAS, Karen Thompson filed with the State Personnel Board of Review (“SPBR”) Case No. 2016-REC-04-0069 now pending and

WHEREAS, Karen Thompson and the Ohio Department of Taxation desire to resolve any and all of their disputes, including, but not limited to, all claims asserted in the litigation between the parties which is identified as Case Number(s) 2016-REC-04-0069.

NOW, THEREFORE, in consideration of the mutual agreements set forth herein, the parties agree as follows:

1. **Parties.** This Agreement is entered into on behalf of, and shall extend to, Karen Thompson, her immediate family, heirs, assigns, personal representatives, executors, agents and administrators (hereinafter collectively referred to as “Thompson”); and to the Ohio Department of Taxation, its successors, assigns, officers, directors, employees and agents, both past and present (hereinafter collectively referred to as “TAX”).
2. **Intent.** Except as specifically set forth in this settlement agreement, the parties wish to bring a complete, final and irreversible end to any and all claims and/or disputes which arose or which could arise from the above-listed Case Number(s), and to reach a full and final settlement of all matters and claims, of any nature, as of the date this Agreement is executed.
3. **Consideration.** In consideration of the mutual promises and agreements set forth herein, the Parties agree as follows:

(a) Thompson agrees that she will remain in her current classification of a Tax Examiner Manager.

(b) TAX agrees to pay Thompson a lump sum payment of \$5,000.00 (five thousand dollars) no later than two (2) pay periods after all parties have signed this agreement. The lump sum payment will be subject to any and all applicable and required deductions.

4. **Release of All Claims and Dismissal of All Charges and Legal Actions.** Thompson does hereby fully, finally and forever release and waive any and all claims and rights which she may have against TAX, its officers, directors, employees, and representatives, both in their individual and official capacities, and does hereby specifically quitclaim, release and forever hold harmless from and against any and all claims, liability, causes of action, compensation, benefits, damages, attorney fees, costs or expenses, of whatever nature or kind which have arisen or which could have arisen from Thompson's employment with TAX or her claims in the above-listed Case Number(s) at any time up to and including the date of execution of this Agreement. Such rights, claims, causes of action or liability shall include, but not be limited to, those arising or which might arise out of intentional infliction of emotional distress, harm or illness, intentional injury or intentional tort, or any other facts; the Fair Labor Standards and Equal Pay Acts; Title VII of the Civil Rights Act of 1964, the Civil Rights Act of 1964 as amended, the Civil Rights Act of 1991 as amended; the United States Constitution; the Civil Rights Acts of 1866 or 1871 (42 U.S.C. Sections 1981, 1983, 1985, *et seq.*); the Americans with Disabilities Act, the Age Discrimination in Employment Act; Chapter 4112 of the Ohio Revised Code and any other provision of the Ohio Revised Code, not filed and existing as of the date of this Agreement; and any other Federal, State, City, County or other local law or ordinance concerning employment, or in any other manner regulating or otherwise concerning wages, hours

or any other terms or conditions of employment, which, (a) have been filed, (b) are now pending, or, (c) could have been filed, relating to any acts which have transpired at any time up to and including the date of execution of this Agreement.

Thompson represents and warrants that she has not assigned or otherwise transferred any right to any other person to assert any claims of any kind or character against TAX, and agrees to indemnify and hold TAX harmless from and against any such claims to be asserted by any other party.

5. **Non-Admission.** The terms set out in the Agreement are a compromise settlement of disputed claims, the validity, existence or occurrence of which is expressly denied by TAX. Neither the terms nor the Agreement shall be deemed or construed as an admission by TAX of any wrongful acts whatsoever by or against Thompson or any other person, nor does any arrangement(s) made with Thompson constitute an acknowledgment of the validity of any claim, charge, liability or cause of action asserted, it being expressly understood that all such claims are in all respects denied by TAX. Likewise, Thompson makes no admission concerning the merits of her appeal by accepting the terms of this Agreement.

6. **General Terms.** The Parties to this Agreement represent and affirm that the only consideration for their agreement and execution are the terms stated above; that no other promise or agreement of any kind has been made to or with any of them by any persons or entity to cause any to execute this Agreement, and that no other compensation, benefits, or prerequisites other than those specified in the foregoing Agreement shall be involved or claimed; that this Agreement shall not be interpreted to render Thompson a prevailing party for any purpose, including but not limited to an award of attorney fees under any applicable statute or otherwise; and that each fully understands the meaning and intent of this Agreement, including but not



limited to their final and binding effect. Thompson further acknowledges that the execution of the Agreement is by knowing and voluntary act.


7. **Construction and Severability.** This Agreement shall be construed according to its fair meaning and not strictly for or against any of the Parties. Should any provision of the Agreement be declared or determined by any court to be illegal or invalid, the validity of the remaining parts, terms, or provisions shall not be affected thereby and the illegal or invalid part, term, or provision shall be deemed not part of the Agreement.

This Agreement sets forth the entire agreement between the Parties hereto, and fully supersedes any and all prior discussions, agreements, transmissions or understandings between the Parties or their representatives.

The undersigned Parties state that they have carefully read the foregoing and understand the contents thereof, and that they execute the same as their own free and voluntary act.
