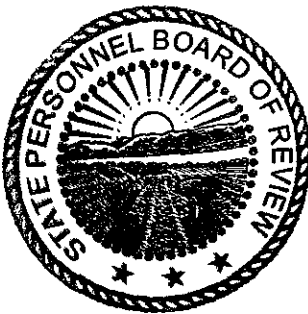
ORDER



REPORT AND RECOMMENDATION

To the Honorable State Personnel Board of Review:

This cause came on for consideration upon Appellee's Motion to Dismiss, filed with this Board on April 17, 2009. Appellant filed an appeal of her removal from employment with Appellee; Appellee asserts that this Board lacks jurisdiction to consider the appeal because Appellant's position fell within the unclassified civil service, pursuant to the provisions of R.C. 124.11(A)(10).

Appellee submitted with its Motion the sworn affidavit of Ty Hinton, the duly authorized Clerk of Courts of Ross County and Appellant's appointing authority. Mr. Hinton's affidavit asserted that Appellant was responsible for handling public money and secured documents as part of her official duties as a Deputy Clerk of Courts. Appellant filed no response to Appellee's Motion to Dismiss to dispute the information provided by Appellee.


R.C. 124.11(A)(10) places into the unclassified service:

. . . deputies of clerks of the courts of common pleas who supervise
or who handle public moneys or secured documents

Based upon the uncontroverted evidence contained in the record, I find that Appellant was a Deputy Clerk who handled public moneys and secured documents, and that her position was, therefore, unclassified. This Board does not possess subject matter jurisdiction over the removal of an unclassified employee since Ohio Revised Code Section 124.03 limits this Board's jurisdiction to actions concerning classified employees.
